Lately, the Chairperson, Governing Body vide note dated November 28, 2022, has approved for further extension of the term of Professor Ravi Toteja as Officiating Principal for a period of 6 months or till the regular Principal is appointed whichever is earlier beyond December 15, 2022. Accordingly, the college has sent the same to the University of Delhi for approval.

32. The process of installation of Solar Panels in the college has been done through Government e-Marketing (GEM) through bidding procedure and an order has been placed with M/s. Talf Solar India Private Ltd. Account an MoU has been signed. The Governing Body of the at its meeting held on March 9, 2022 had earlier granted permission to install the Solar Panel in the college.

B. Considered and approved:

1. The request of Ms. Namrata Arora, Officiating Librarian not to recover the excess amount paid to her after placing her in the Librarian Scale.

On Retirement of Ms. Veena Saini, the incumbent Librarian on September 30, 2013, the post of Librarian had fallen vacant. Ms. Namrata Arora, Professional Assistant in the college library had requested for the grant of pay scale of Librarian at entry level as per 7th Pay Commission equivalent to Rs.15600-39100 with a grade pay of Rs.6000/-(pre-revised as per VI Pay Commission).

Accordingly, the Governing Body at its meeting held on November 13, 2018 approved her request and Ms. Namrata Arora was granted ad-hoc promotion as Librarian and was placed in Librarian Scale and was granted Rs. 57600/- basic pay in Pay Level 10 of Pay Matrix with effect from November 13, 2018 for a period of one year or till the appointment of Librarian is made whichever is earlier. However, the University of Delhi South Campus vide its letter No.DULS/ULO/2019/82 dated 21.02.2019 informed that College Librarian is non-vacational academic and not a promotional post and is appointed by a properly constituted Selection Committee and approved by the University/Governing Body of the college. Therefore she cannot be placed in the Librarian Scale.

Ms. Namrata Arora was informed accordingly and she submitted a representation which was also sent to the University of Delhi vide college letter No.ANDC/814 dated 20.01.2021. In response to the college clarification letter No. ANDC/2019/2150 dated 26.11.2019, the University of Delhi South Campus vide its letter No. CS-SDC/149/2020/1058 dated 21.08.2020) again informed that the post of Librarian can be filled only through Direct Recruitment. Her promotion to the College Librarian on ad-hoc basis is not technically correct as the post is not in the ladder of Promotion for Professional Assistant. The University advised for the reversion of the incumbent to the original Post of Professional Assistant & excess amount of salary paid to Ms. Namrata Arora may be adjusted/recovered.

The Governing Body discussed the matter thoroughly and resolved to recover the excess payment in installments as per rules after adjusting Officiating Allowance due to her.
