2.5.2 – Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

Evaluation in internal assessment is done by Open Book Examination, Online Multiple Choice Questions, tests and presentations. The students are continuously evaluated for their performance and regularity in the practical classes and are marked as internal assessment. The semester end practical examinations are evaluated along with an external examiner provided by the University. The students check their internal assessment marks on ERP. Every student signs the hard copy of the internal assessment before it is mailed to examination branch of University. Students are free to report any discrepancy in their marks to the office/teacher concerned within a stipulated time. Evaluation in internal assessment is done by Open Book Examination, Online

Multiple Choice Questions, tests and presentations. The students are continuously evaluated for their performance and regularity in the practical classes and are marked as internal assessment. The semester end practical examinations are evaluated along with an external examiner provided by the University. The students check their internal assessment marks on ERP. Every student signs the hard copy of the internal assessment before it is mailed to examination branch of University. Students are free to report any discrepancy in their marks to the office/teacher concerned within a stipulated time. The College internal assessment committee oversees the final moderation of the internal assessment marks submitted by each department to ensure the implementation of the evaluation reforms. The college provided TABLETS on perpetual basis to all permanent teachers and semester-wise issue/return basis to all adhoc-teachers to facilitate academic works like online marking of attendance, uploading of internal assessment assignments, upload and access to e-content, timetable, use of Learning Management System for conducting online examination, result analysis, online leave applications, access to ownleave ledger, SMS and meeting notices, online service request etc.

2.5.3 – Academic calendar prepared and adhered for conduct of Examination and other related matters (250 words)

The academic calendar prepared by the University is shared by the college at the beginning of the session and the college strictly adhere to it for all its working and non-working days. The entire departmental activities is planned keeping the academic calendar in mind. Exams including practicals are conducted as per University guidelines. The examination committee constituted in staff council along with the support of teaching and non-teaching faculty members contributes in the smooth conduct of fair exams. Guidelines related to Internal Assessment exams are followed by students and faculty member in the best interest of students. Internal tests are spread out evenly and properly spaced so as to avoid pressuring the students with too many examinations. There is an internal assessment committee in the college who addresses the student's grievances and also looks after any discrepancies. Students are timely updated about the notices related to internal assessment, library and laboratory clearance besides facilitating issuance of examination hall tickets etc through ERP. Each student is assigned a faculty member in the name of mentor at the beginning of each session to discuss any of their problems .The list for such mentor -mentee is shared to the students through departmental notice boards. Notices in detail mentioning duration, basic requirement, stipend etc. for summer Projects (under ELITE flagship scheme), projects under faculty members from different streams besides those with external laboratories and/or companies are published online as well as offline.

The first audit is internal and carried out by the college appointed Chartered Accountant (CA).
