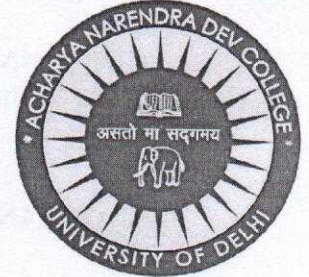

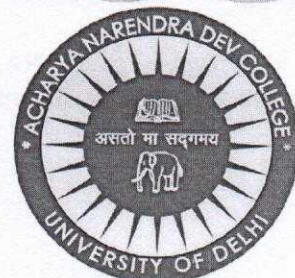

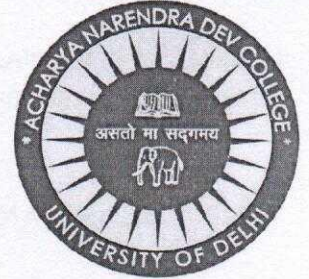

## INSPIRE-Scholarship for Higher Education— Post-Offer Implementation Guidelines for Scholars

INSPIRE-Scholarship for Higher Education (INSPIRE-SHE) are offered to pursue undergraduate (UG) studies and continued up to postgraduate (PG) studies, based on Class 12th standard examination results (top 1%) of respective Boards or within eligible rank in chosen few competitive examinations such as JEE (main), JEE (advanced), NEET (AIPMT) and securing admission in science stream (in any of science course or its combination out of 18 identified subjects) at any recognized Colleges or Universities or Academic Institutions in the country.

INSPIRE-SHE shall be regulated with the following guidelines:

**1. Mode of Intimation to Scholar:** All selected candidates shall receive a Provisional Offer letter on their INSPIRE web portal account, informing that they are selected for the scholarship. The selected students are required to log into the online portal to download the offer letter. The list of selected and rejected students will also be displayed on Home page of INSPIRE website. ## INSPIRE Scholarship – Post-Offer Implementation Guidelines for Scholars

INSPIRE Scholarship, offered to pursue undergraduate (UG) studies and continued up to postgraduate (PG) studies, based on Class 12th standard examination results (top 1%) of respective Boards or within eligible rank in chosen few competitive examinations such as JEE (main), JEE (advanced), NEET (AIPMT) and securing admission in science stream (in any of science course or its combination out of 18 identified subjects) at any recognized Colleges or Universities or Academic Institutions in the country.

INSPIRE Scholarship shall be regulated with the following guidelines:

**1. Mode of Intimation to Scholar:** All selected candidates shall receive a Provisional Offer letter on their INSPIRE web portal account, informing that they are selected for the scholarship. The selected students are required to log into the online portal to download the offer letter. The list of selected and rejected students will also be displayed on Home page of INSPIRE website. The selected candidates have to upload the required documents on their INSPIRE web-portal account in prescribed time period (i.e. time period mentioned in offer letter) for further consideration.

**2. Confirmation of Scholarship Offer:** All offers made initially will be '**Provisional**'. This will be confirmed based on the subjects/courses pursued in the B.Sc./B.S./Int. M.Sc./Int. M.S. course and upon submission of the first year B.Sc./B.S./Int. M.Sc./Int. M.S. examination Mark-sheets by the Scholar. In case of otherwise, the offer stands invalid and no communication would be made separately in this regard.

**3. Re-admission or Change of College/ University:** Any change or re-admission to another College/ University/ Academic Institute within the same academic year is acceptable, provided the scholar pursues subjects out of identified 18 nos. subject(s). The Offer would stand invalid in case this change or re-admission occurs in the next academic year and thereon, or subject(s) pursued is/ are beyond the 18 identified subjects. In such a case, there will be no scope for restoration of the offer and no communication would be made separately to the scholar.

**4. Gap Year between B.Sc. and M.Sc.:** After completion of three years of B.Sc. program, students may join M.Sc. course (Natural and Basic Sciences only as per list) anywhere in the country. The scholarship will be discontinued in case of one year break or Gap between B.Sc. and M.Sc. course.

**5. Opening & Submission of Bank Account:** Scholars are required to open a regular Bank Account within India at any branch of State Bank of India, exclusively on Scholar's name. [opening of Joint A/c may be allowed only in case of Minor Scholars as under Guardian (U/G)] The scholars must submit the **Accounts details in the specified format** (through the online portal only) along with the **self-attested photocopy of front page of Bank Passbook and Aadhaar or Aadhaar Enrolment slip, within 120 days** of this Offer.

A maximum period of 120 days would be allowed to a scholar for the completion of Bank Account related formalities and the offer of the scholarship would stand cancelled in case the scholar fails to submit the account details within this time period. After the due date, the names of such scholars shall be notified at the website: [www.online-inspire.gov.in](http://www.online-inspire.gov.in) as "**Cancelled Scholarship**" and no further communication shall be made separately to such scholars. All Scholars are also requested to visit their INSPIRE webportal regularly to see notifications on their Accounts related issues such as Invalid Accounts/ No Frills Accounts/ Joint Account/ Dormant Account and to take necessary actions within one month of such notification.

**6. Payment and Continuation of Scholarship:** The Scholarships for 1<sup>st</sup> and 2<sup>nd</sup> years are paid together at the second year of the scholars' undergraduate course. The Scholarship is paid on the basis of the following:

b) For continuation of INSPIRE Scholarship, the scholar shall (i) pass in all subjects in first attempt, and (ii) secure minimum 60% marks or 7.0 GPA (on a 10.0-point scale) in his/her annual examinations (or 2 semesters) in B.Sc. General /B.S. /Int. M.Sc. /Int. M.S. or M.Sc. examinations every academic year, failing which the scholarship for the next academic year will not be paid. If the grading to percentage conversion factor/ formula is not provided along with the mark sheet, then the CGPA will be evaluated on 10.0-point scale.

c) In the case of **B.Sc. Honours**, for continuation of INSPIRE Scholarship, the scholar shall (i) pass in all subjects in first attempt, and (ii) secure minimum 60% marks or 7.0 GPA (on a 10.0-point scale) in his/her annual examinations (or 2 semesters) in **Honours subject** in B.Sc. /B.S. /Int. M.Sc. /Int. M.S. or M.Sc. examinations every academic year, failing which the scholarship for the next academic year will not be paid.

d) If a scholar has failed or could not attend the annual/ any of the semester examination(s) in that year, the INSPIRE Scholarship for the next academic year will not be paid. However, scholarship will be released in the next to next academic year, provided the scholar's academic performance in next academic year is within the aforesaid eligibility norm mentioned at 5b and 5c.

e) The maximum tenure of INSPIRE Scholarship is five years. Except Integrated MSc or Integrated MS course, the scholarship shall continue at PG level only after successful completion of 3 years BSc or 4 years BS course, for another two years or one year, depending upon the course pursued at the UG level. The Scholar needs to maintain their academic performance as per clause 5b, 5c and pursue only the identified subject(s) at the MSc level. If it is otherwise, the continuation of scholarship at the PG level stands cancelled automatically and no representations shall be entertained in this regard.



#### 7. **Submission of Performance Reports and Mark-sheets:**

- a) Except for very 1<sup>st</sup> year, scholarship for any academic year shall be paid to the scholar only after the evaluation/approval of (i) Performance report and (ii) Mark Sheet (annual basis or two semesters in one academic year) of B.Sc. /B.S./Int. M.Sc./Int. M.S. or M.Sc. course for previous academic year.
- b) The Scholar shall submit above (at 6a) referred documents altogether. Scholarship will not be processed in case any one of the aforementioned documents is not submitted.
- c) Scholars are advised to submit their yearly Mark-sheets and performance related documents on-time, preferably within 2 months of announcement of yearly results to facilitate the payment of scholarship by DST-INSPIRE. However, keeping in view the diverse time schedules of the examinations in Universities across the country, scholars are permitted a maximum period of twelve (12) months to submit their Performance Report and Mark-sheets for a given completed academic year ending June every year. As an example, 2014 batch enrolled student is expected to submit the First Year Performance Report and First Year Mark Sheet before 30th June 2016. This analogy can be followed by other batches for the release of the INSPIRE Scholarship.
- d) If a scholar does not submit his/her annual Performance Reports and Mark-sheets for two consecutive academic years, the offer of scholarship shall be withdrawn.
- e) Provisional Mark-sheets will not be considered.
- f) In case of non-availability of original mark sheets, self-attested internet copy of mark sheet duly attested by Controller of Examination or Registrar of college/university should be uploaded on the portal.

**8. Research Projects Mentorship for Scholars:** The main objective of INSPIRE/SHE program is to encourage young students to pursue Research as a career. In order to inculcate scientific values and develop scientific temper, the scholars are required to enroll in a Research Project every year. To avail the mentorship grant, the scholars are expected to do project work under a Research Supervisor (Mentor) during summer vacation period, in any recognized Universities or Institutes or Research Laboratories/ Centres of their choice outside their parent institutions either in India or abroad. The scholar may avail institutional arrangement or arrange both Mentoring Institution and Mentor to carry out this. Consumables required to carry out project work, if recommended by the Mentor, will be paid from the Mentorship Grant, either to the Institute where project work is pursued or to the Scholar directly.

**(8.1) For students doing a project in India:** The expenses related to travel, accommodation and consumable expenses are reimbursed to the student within the mentorship grant. Please note that no food expenses are covered by this grant, as the students receive scholarship during this period. The DST-INSPIRE shall make provision of Rs 20,000/- per annum as Mentorship Grant to each INSPIRE Scholar to carry summer vacation research work every year. The minimum tenure of the project must be six to eight weeks. The duration of the project must be clearly mentioned in the project report.

The Mentorship Grant shall be reimbursed either to the mentoring institutions as a bench fee to accommodate the INSPIRE scholar or directly to the Scholar to carry out research work. After completion of the project work at the Institute or University or Research Laboratory under a Research Supervisor (Mentor), the candidate should submit the following documents to the DST for reimbursement of the Mentorship Grant.

**(a)** A letter attested by the Research Supervisor and Head of Institution where the scholar is enrolled for the project. Duration of the project i.e. date of commencement and date of completion must be mentioned in the certificate.

**(b)** A report outlining the objectives and results of his/her project.

The scholars are requested to specify clearly to whom the mentorship grant must be reimbursed (Mentoring Institution or scholar).

**(8.2) For students doing a project Abroad:** Students at 4<sup>th</sup> or 5<sup>th</sup> year of the Scholarship may be allowed to carry our research project in any Institute/ University/ Laboratory abroad by utilizing the Mentorship Grant available for five years on pro-rata basis. If the sponsoring institute pays any stipend or travel grant, only the difference between the support received from all sources put together and actual expenditure will be reimbursed from the Mentorship Grant. The DST-INSPIRE shall make provision of Rs 20,000/- per annum or (Rs 1,00,000/- in 5 years) as Mentorship Grant to INSPIRE Scholar to carry summer vacation research work abroad. The Mentorship Grant shall be reimbursed either to the mentoring institutions as a bench fee to accommodate the INSPIRE scholar or directly to the Scholar to carry out research work, in case a Scholar does not utilize this grant in any year during the tenure of INSPIRE Scholarship, it can be carried forwarded until the completion of the tenure of INSPIRE Scholarship. Student is eligible only to receive the expenditure, which he has incurred for basic research work. There is no provision for reimbursement of the unutilized grant to the student. After completion of the project work at the Institute or University or Research Laboratory under a Research Supervisor (Mentor), the candidate should submit the following documents to the DST for reimbursement of the Mentorship Grant.

**(a)** A letter attested by the Research Supervisor and Head of Institution where the scholar is enrolled for the project. Duration of the project i.e. date of commencement and date of completion must be mentioned in the certificate.

**(b)** A report outlining the objectives and results of his/her project.

**(c)** Travel Bill (Air Fare Tickets, Boarding Pass).

1. The student shall be a student pursuing **B.Sc.(H) Chemistry VI** semester at ANDC.
2. Minimum merit score of 80% (overall score till Vth semester) is the first criterion.
3. Minimum Attendance should be 75% of the classes held.
4. Active Involvement of student in college activities.

**For Smt.Snehlata Gupta Fellowship**

1. The student shall be a student pursuing **B.Sc.(H) Chemistry III** semester at ANDC.
2. Their family income is less than Rs. Five lakhs per annum.
3. Minimum merit score should be 60 % and above in Ist year.
4. Minimum Attendance should be 75% of the classes held.


Applicants for the scholarship/fellowship will be selected after an Interview by the Committee.

original amount of the Fund shall be returned, without any condition, to the Donor or his nominee or legal heirs for further disposal.

Guidelines for determining eligibility of the students for grant of above scholarship can be as under:

**(a) Academics Track Record**

Passing qualifying examination in the first attempt and securing at least 70% marks (overall) or equivalent grade.

**(b) Performance in the studies**

Attendance in the class should not be less than 75% and conduct and character should be acceptable to the Teacher In-charge of the course and Principal of the College.

These guidelines may be revised periodically by the Committee keeping in view the changed circumstances.

The Criteria for identifying the candidates for grant of Scholarship will be as under:

1. In all, there will be two scholarships that can be awarded to two students pursuing a regular course in Department of Electronics.
2. The amount of each Scholarship will be Rs.15,000/- per year. This amount may be revised every year by the Committee keeping in view the income earned by the Fund. Part of the Scholarship will be used for paying/reimbursing the college/University Fee (excluding refundable security deposit).
3. Applicants for the scholarship will be selected after an Interview by the Committee.
4. Applicants selected will be reviewed by the Committee for continuation of the scholarship in the subsequent year.
5. Candidates selected for scholarship will undertake to (i) conduct and behave themselves in the manner which is in conformity with the college discipline or as directed by the Teacher In-charge / Principal and (ii) attend at least 75% of classes held, failing which scholarship remaining unpaid shall not be paid to them and also their refundable security deposit lying in the College shall be forfeited by depositing the same to the account of Fund.

The decision of Committee regarding selection of candidate for grant of Scholarship, amount of each Scholarship, forfeited of Scholarship in case of default on the part of selected candidates, etc. shall be final.

To enable the college authorities to commence operation of above Fund with immediate effect, I shall pay Rs. 30,000/- (over and above corpus fund of Rs.5,00,000/-) towards two scholarships of Rs.15,000/- each.





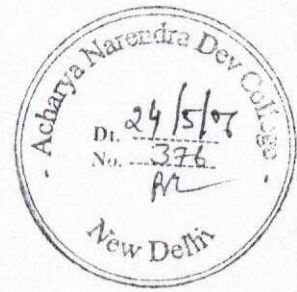

## “MISS TEENA GUPTA MEMORIAL SCHOLARSHIP FUND”

Miss Teena Gupta had been working as a Lecturer in the Department of Computer Science of Acharya Narendra Dev College (University of Delhi) for nearly last three years. She had been also a student of Ph.D course in the Department of Computer Science, D U under the supervision of Dr Naveen Kumar and Dr Ramesh Aggarwal.

Prior to completion of her M.Sc (Informatics) from Institute of Informatics and Communication, University of Delhi (South Campus) in the 2003, Miss Teena Gupta had been a student of B.SC (Hons) Electronics (1998-2001) of Acharya Narendra Dev College (University of Delhi). She passed all her examinations in the first attempt with merit and was awarded prizes not only by the Acharya Narendra Dev College but also by the University of Delhi.

Unfortunately she has died on 11.03.2006 at the young age of 25 years.

With a view to perpetuate her memory I, being her father, wish to set up a fund by donating a sum of Rs 5, 00,000/= (Rs Five Lacs) only. The Committee for managing the fund shall comprise of following persons:

3. Teacher in Charge of Computer Science
4. Convener, Fellowship Program and Award Committee
5. Representative of the Governing Body of the College.
6. One person nominated by the donor or any other member of the family of Late Miss Teena Gupta

Quorum for the above Committee shall be four members. As far as possible, decision will be taken unanimously by the Committee. 5



Whenever the nominee of the family of Late Ms. Teena Gupta is not able to attend the meeting, concurrence of the Nominee or the donor shall be obtained before executing the decision of the Committee.

Criterion for granting Scholarship shall be Academic Track Record in Qualifying examination, financial backwardness and performance in studies.

Religion, caste or gender of the students shall never be a criterion for considering and granting scholarships. Accordingly, information regarding the same need not be called by the authority competent to sanction scholarships.

Scholarships shall not be granted to the students:

- a. Who have passed their qualifying examination by distance learning or as external candidates.
- b. Who are studying in self financed courses.
- c. Who are studying in courses other than
  - (1) undergraduate
  - (2) Computer Science or Electronics.
- d. Who are studying Under Graduate Courses as part time or external students.

In rare of rarest circumstances wherein the Committee feels that the Objective for which this fund is set up, can not be fulfilled with out changing the above basic structure/ features, original amount of the Fund shall be returned, with out any condition, to the Donor or his nominee or legal heirs for further disposal.

Guidelines for determining eligibility of the students for grant of above scholarship can be as under:

- (a) Academic Track Record  
Passing qualifying examination in the first attempt and securing at least 60 % marks (overall) or equivalent grade.
- (b) Financial Backwardness  
The monthly earned income of both the parents should not be more than Rs 6000/- (Six Thousand).  
This amount can be revised between 5 % and 10 % every year depending upon inflationary conditions prevailing in the country.
- (c) Performance in the studies  
Attendance in the classes held should not be less than 75 % and Conduct and character of the student should be acceptable to the Teacher In Charge of the relevant Course and Principal of the College.

These guidelines may be revised periodically by the Committee keeping in view the changed circumstances. S



The Criterion for identifying the candidates for grant of Scholarship will be as under:

1. Scholarships will be awarded only to the students of B.Sc (H) Electronics and B.Sc (Program) Applied Physical Science (earlier B.Sc. (G) Computer Science).
2. In all, there will be six scholarships – three each for B.Sc.(H) Electronics (one each for Part I, II & III) and B.Sc. (Program) Applied Physical Science (one each for Part I, II & III)

In case no eligible candidate is available for a particular Part, the scholarship can be given to candidates of other Parts.

However the number of scholarships will remain same, for each discipline (i.e. three for each discipline).

3. The amount of each Scholarship will be Rs. 5000/- (Five Thousand) per year.

This amount may be revised every year by the Committee keeping in view the income earned by the Fund.

Part of the Scholarship will be used for paying/reimbursing the College/University Fee (excluding refundable security deposit) and remaining amount will be used for purchasing books through the Teacher in Charge of the concerned Department.

4. Applicants for the scholarship will be selected after an interview by the Committee.
5. Applicants selected will be reviewed by the Committee for continuation of the scholarship in the subsequent year.
6. Candidates selected for scholarship will undertake to:

(i) conduct and behave themselves in the manner which is in conformity with the College discipline or as directed by the Teacher in charge/Principal, and

(ii) attend at least 75% of classes held,

failing which scholarship remaining unpaid shall not be paid to them and also their refundable security deposit lying in the College shall be forfeited by depositing the same to the account of the Fund.

The decision of the Committee regarding selection of candidate for grant of Scholarship, amount of each Scholarship, forfeiture of Scholarship in case of default on the part of selected candidates, etc. shall be final.

To enable the college authorities to commence operation of above Fund with immediate effect, I shall pay Rs. 30,000/- (Thirty Thousand) over and above corpus fund of Rs.5,00,000/- (Five lacs) towards six scholarships of Rs. 5000/- (Five Thousand) each.

2. The Endowment shall be called as **Shri Sultan Chand Memorial Scholarship Endowment.**
3. The Endowment is of Rs. 50,000/- to be invested in Fixed Deposits in PUBLIC SECTOR BANKS yielding Quarterly interest income @ 7.25% p.a.
4. The annual interest accrued therefrom shall be utilised for the award of scholarship of Rs. 3,500/- p.a. tenable for one year. It shall be awarded every year to a student of B.Com. Hons. III<sup>rd</sup> year in Acharya Narendra Dev College.
5. The Scholarship shall be awarded strictly by merit to a student of B.Com. Hons. III<sup>rd</sup> year who secures the second highest percentage of marks, being above 70 (Aggregate of internal and external in all the papers), in the college in B.Com. Hons. II<sup>nd</sup> year University Examination in the first attempt in the year immediately preceding. If in any year two or more candidates secure equal number of marks, the value of the Scholarship shall be divided equally amongst them. In case the student securing the second highest percentage of marks in B.Com. Hons. II<sup>nd</sup> year University Examination is in receipt of any other Scholarship or is unwilling to accept this Scholarship, the same shall be awarded to the next eligible candidate strictly by merit.
6. No student shall be eligible for this Scholarship if he/she already holds a Scholarship awarded by Delhi University or any other University of the Central Govt. or any State Govt. or a private Body except freeship.



7. In case student awarded this Scholarship accepts any other Scholarship/financial assistance from any other source, he/she shall be required to surrender this Scholarship and also refund the amount received by him/her on account of this Scholarship from the date he / she accepts the other Scholarship / financial assistance.
8. In case student discontinues studies without valid reasons, the Scholarship also is discontinued immediately.
9. In case Scholarship falls vacant, it may be awarded for the residuary period to another eligible student by merit.
10. Any amount accruing from the interest from the endowment and not spent in any year shall be added to the corpus of the endowment fund.
11. The payment of the Scholarship amount will be made to the student on presentation of certificate to the effect that during the period he/she was not in receipt of any other Scholarship or financial assistance from any other source.
12. A report of the award of Scholarship will be furnished to the donor each time.



Criterion for granting Scholarship shall be

1. Merit is the first criteria, meaning student scoring the higher gets the priority.

Religion or caste of the students shall never be a criterion for considering and granting scholarship. Accordingly, information regarding the same need not be called by the authority competent to sanction scholarships.

Scholarship shall not be granted to the student:

- a) Who have passed their qualifying examination by distance learning.
- b) Who are studying Under-graduate courses as part time or external student.

In rare of rarest circumstances wherein the Committee feels that the Objective for which this fund is set up, cannot be fulfilled without changing the above basic structure/ features, the original amount of the Fund shall be returned, without any condition, to the Donor or his nominee or legal heirs for further disposal.



Guidelines for determining eligibility of the students for grant of above scholarship can be as under:

**(a) Academics Track Record**

Passing qualifying examination in the first attempt and securing at least 65% marks (overall) or equivalent grade.

**(b) Performance in the studies**

Attendance in the class shall not be less than 75% and conduct and character shall be acceptable to Principal of the College.

These guidelines may be revised periodically by the Committee keeping in view the changed circumstances.

The Criteria for identifying the candidates for grant of Scholarship will be as under:

1. In all, there will be one scholarship that can be awarded to a student pursuing a regular course B.Sc Life Sciences with passing qualifying examination in the first attempt and securing at least 65% marks (overall) or equivalent grade.
2. The amount of each Scholarship will be Rs.6,000/- per year. This amount may be revised every year by the Committee keeping in view the income earned by the Fund. Part of the Scholarship will be used for paying/reimbursing the college/University Fee (excluding refundable security deposit).
3. Applicant for the scholarship will be selected after an Interview by the Committee.
4. Applicant selected will be reviewed by the Committee for continuation of the scholarship in the subsequent year.
5. Candidate selected for scholarship will undertake to (i) conduct and behave themselves in the manner which is in conformity with the college discipline or as directed by the Teacher In-charge / Principal and (ii) attend at least 75% of classes held, failing which scholarship remaining unpaid shall not be paid to them and also their refundable security deposit lying in the College shall be forfeited by depositing the same to the account of Fund.

The decision of Committee regarding selection of candidate for grant of Scholarship, amount of each Scholarship, forfeiting of Scholarship in case of default on the part of selected candidates, etc. shall be final.



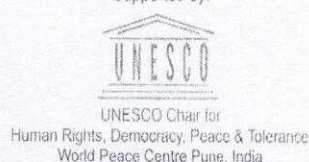

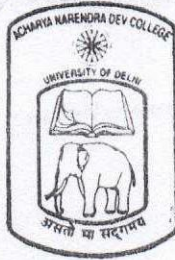

2. Second scholarship to be awarded to the most needy student who is also excellence in studies.






