Directorate of Higher Education, GNCTD gave in principle approval for this capacity expansion vide letter no. DHE-13(3)/ANDC/Cap.Exp/2016-17/922 dated 19<sup>th</sup> May 2016 and DHE-13(3)/ANDC/Cap.Exp/2016-17/1493 dated 06<sup>th</sup> June 2016 and to further follow up the matter with University of Delhi. College has communicated this in principle capacity expansion approval to University of Delhi and has admitted students as per this intake in the above courses for the academic session 2016-17.

Further, University of Delhi approved B.Tech. courses in Electronics and Computer Science under Four Year Undergraduate Programme(FYUP) in the academic year 2013-14. After the rollback of FYUP in 2014-15, all the undergraduate courses were reverted back to three year duration except B.Tech. Courses which continued as four years. College has taken due approval from the regulatory body, AICTE. AICTE has approved these courses for only the enrolled batch of students. These courses are run under Department of Electronics and Computer Science in the college. This batch shall be passing out in 2016-17.

In view of this situation, College needs to appoint additional teachers over and above the sanctioned teaching posts of 115 to support the teaching learning process for the academic session 2016-17. The teachers in the department running B.Tech course shall be doing additional direct teaching over and above the UGC norms of 14 hours and 16 hours per week for Associate Professors and Assistant Professors respectively and still will require extra teachers. The additional teacher requirement for the academic session 2016-17 is as under:

College will follow up the sanction of additional teaching posts due to enhancement in the intake capacity by 79 with DHE and seek due approvals before proceeding for regularization.
